I was arrested as a Federal fugitive in violation of the 14th Amendment, 1970, which allowed for the removal of jurisdiction after 1970. NO FEARS ACT and WILLIAMS AR 2001 Army Commission. I have violated the Atomic Energy Act of 1954, which allowed for the removal of jurisdiction after 1954, approved under TRIAL BY JURY.

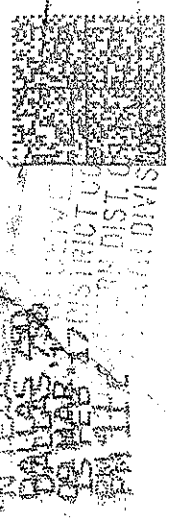
