# 1 Introduction

The Electronic Filings in Administrative Proceedings (eFAP) application is a system that assists the U.S. Securities and Exchange Commission (SEC) Office of the Secretary (OS) staff to receive, review, and process submitted filings. This document provides instructions and helpful information for the public registered users of the eFAP system.

## 1.1 eFAP Help Desk

If you experience technical difficulties while using eFAP, (e.g., web browser questions, authentication, or timeout issues, etc.), please call the eFAP Help Desk at 202-551-EFAP (3327) for assistance.

# 2 Register as a User with eFAP

In order to use the eFAP application, all users must register with eFAP. The eFAP registration process is completed in two stages: (1) creating an account in login.gov and (2) registering in eFAP. login.gov is a U.S. Government shared service that SEC and other government agencies are using to provide public users with private and secure online access to participating government programs such as eFAP. Each stage of the registration process and how to access eFAP is described below.

## 2.1 Access eFAP

The eFAP application is accessed through an eFAP intermediate page located on SEC.gov website. This section discusses how to access the eFAP intermediate page and the eFAP application.

- 1) Click on the **SEC.gov** link (<https://www.sec.gov>) to open the website. Hover over **Enforcement** in the top navigation menu and select **Administrative Proceedings**.

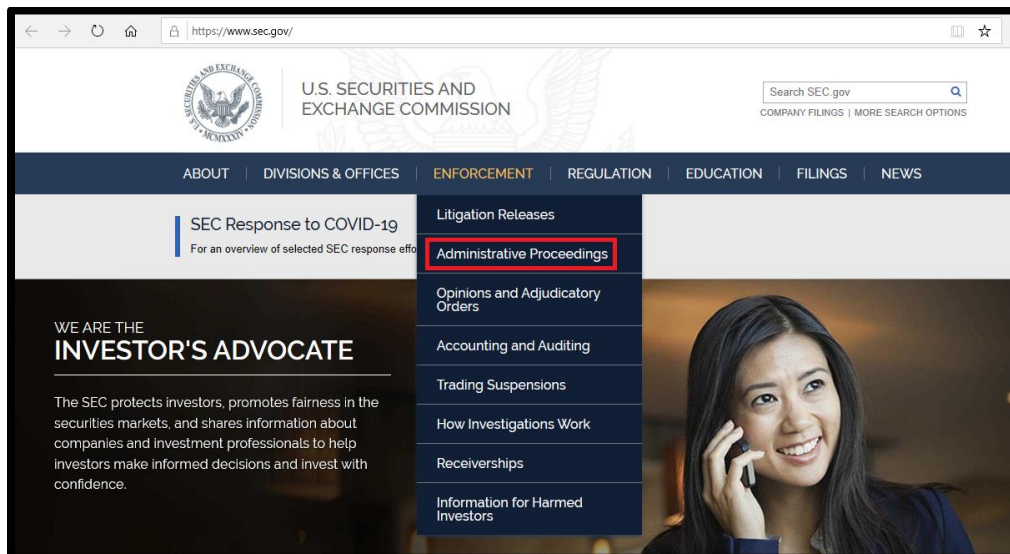


Figure 1: SEC.gov home page – Administrative Proceedings under Enforcement drop-down

- The **Administrative Proceedings** page will appear. Click on the **Electronic Filings in Administrative Proceedings (eFAP)** link located on the right side of the page under **Quick Links**.

**NOTE: The *Electronic Filings in Administrative Proceedings (eFAP)* link is also located under the Quick Links of the following SEC.gov pages: *ALJ Initial Decisions, ALJ Orders, Administrative Proceeding Documents, Opinions and Adjudicatory Orders, and Enforcement.***

- The eFAP intermediate page will appear. The page contains links to SEC Rules of Practice, a PDF file on filing electronically, the latest eFAP user manual, and a Frequently Asked Questions (FAQ) document. The page also contains a link that provides access to the eFAP application. Click on the **Submit** link.

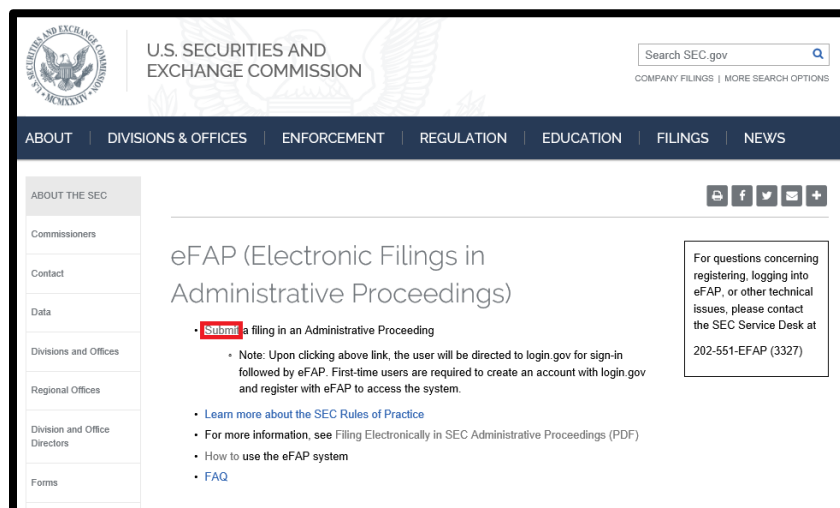


Figure 3: eFAP Intermediate page – Submit link

- The **eFAP Acceptance Disclaimer** page will appear. Click the **Accept** button.

5) The **login.gov-eFAP Sign-in** page will appear. Proceed to section 2.2.

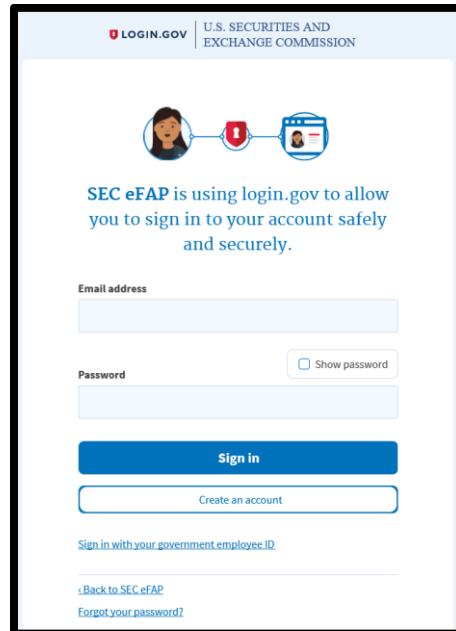


Figure 5: login.gov-eFAP Sign-in page

## 2.2 Creating an account in login.gov

Some users may already have an account within login.gov. This established login.gov account may be used with eFAP if the email address associated with the account is the same email address you provided, or will provide, to the SEC OS. If this is the case, you just need to sign-in and then proceed to section 2.3.

For those that don't have a login.gov account or need to make a new login.gov account with the email that you provided, or will provide, to the SEC OS, you will click the **Create an account** hyperlink, located below the **Sign-in** button, on the login.gov-eFAP **Sign-in** page. The multiple steps in the account creation process are detailed at the following login.gov webpage: <https://www.login.gov/help/creating-an->

[account/how-to-create-an-account/](#). If you successfully complete the steps of the login.gov account creation process, you will be taken to login.gov **you've created an account** page. Click the **Continue** button and proceed to section 2.3.

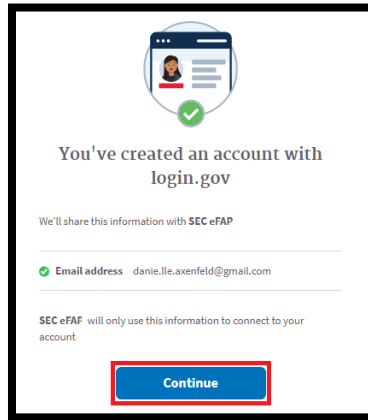


Figure 6: Successful login.gov Account Creation page – Continue button

## 2.3 Register within eFAP

Either through signing in with your existing account, or by creating a login.gov account and clicking the **Continue** button on the **you've created an account** page, you will be taken to the eFAP **Terms and Conditions of Use** page.

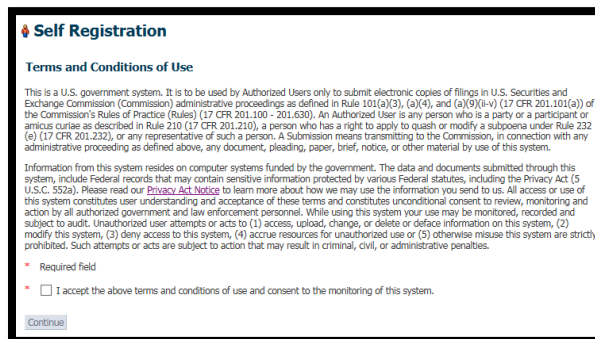


Figure 7: Terms and Conditions of Use page

- 1) Read the Terms and Conditions of Use, click the checkbox, and then click the **Continue** button.

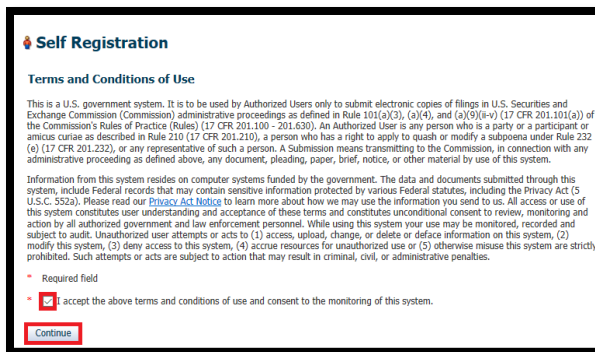


Figure 8: Terms and Conditions of Use page – acceptance checkbox clicked and Continue button enabled

- 2) The **User Registration** page will appear. This page is where you will enter your account information.



*NOTE: To cancel the registration process at any point, click the **Cancel** button on the bottom of the page. If **Cancel** is clicked, you will be sent to the generic **login.gov Sign in** page where you should close your browser.*

3) Enter your information in the following required fields (indicated with a red asterisk [\*]):

- First Name
- Last Name
- Phone Number

*NOTE: Data can be entered into any of the optional fields.*

4) After completing all required fields, click the **Register** button, which becomes enabled once text has been entered into all required fields.

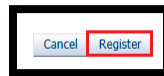


Figure 10: User Registration page – Register button enabled

- 5) If there are no errors in the fields, clicking the **Register** button will take you to the **Self Registration Success** page.
- 6) Click the **Proceed to eFAP** button to be taken to the My eFAP page as shown in Figure 13. Section 4 discusses this page.

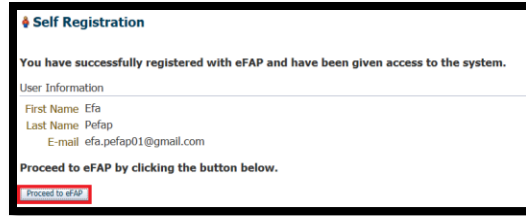


Figure 12: Self Registration - Successfully Registered page - Proceed to eFAP button

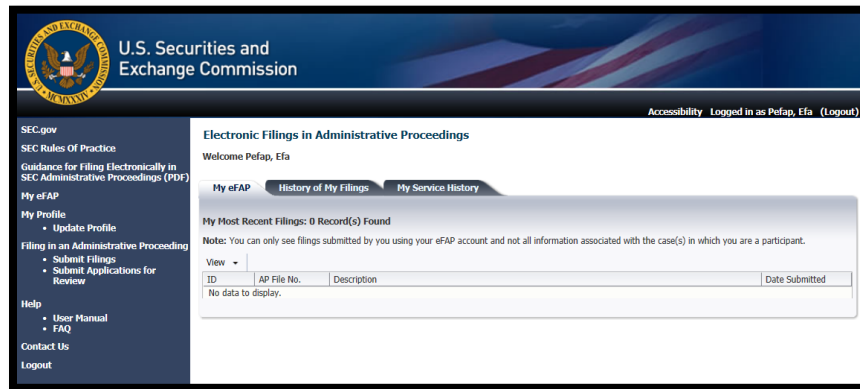


Figure 13: My eFAP page

### 3 Sign in as a Registered User

In order to sign into eFAP, you must enter the email address and password associated with your eFAP account. Your password is the one you used during the registration process or the latest password you updated it to. This section details the specific steps for signing into the eFAP system.

- 1) Upon clicking the the **Submit** link on the eFAP intermediate page (as discussed in Section 2.1) or the eFAP hyperlink (<https://www.sec.gov/eFAP>), your internet browser will take you to the **eFAP Acceptance Disclaimer** page.
- 2) Click the **Accept** button.

- 3) The login.gov-eFAP **Sign-in** page will appear. [Refer to the following login.gov webpage regarding sign in through login.gov: <https://www.login.gov/help/signing-in/how-to-sign-in/>.] Enter your username and password, and click the **Sign In** button.




Figure 15: login.gov-eFAP Sign-in page – Sign In button




Figure 16: login.gov-eFAP security code page

- 4) The page associated with the authentication method you selected during the login.gov creation process will appear. Shown in Figure 16 is the method where a security code is texted to your cell phone. For this authentication method, enter the code sent to your cell phone and click the **Submit** button.

- 5) If you entered the correct code (or successfully completed the authentication method you selected), the **My eFAP** page (described in the next section) will appear.

## 4 My eFAP

After successfully signing in through login.gov-eFAP, you will be taken to the **My eFAP** page. This is the main “landing page” for eFAP registered users, and consists of three (3) tabs: **My eFAP**, **History of My Filings** and **My Service History**.

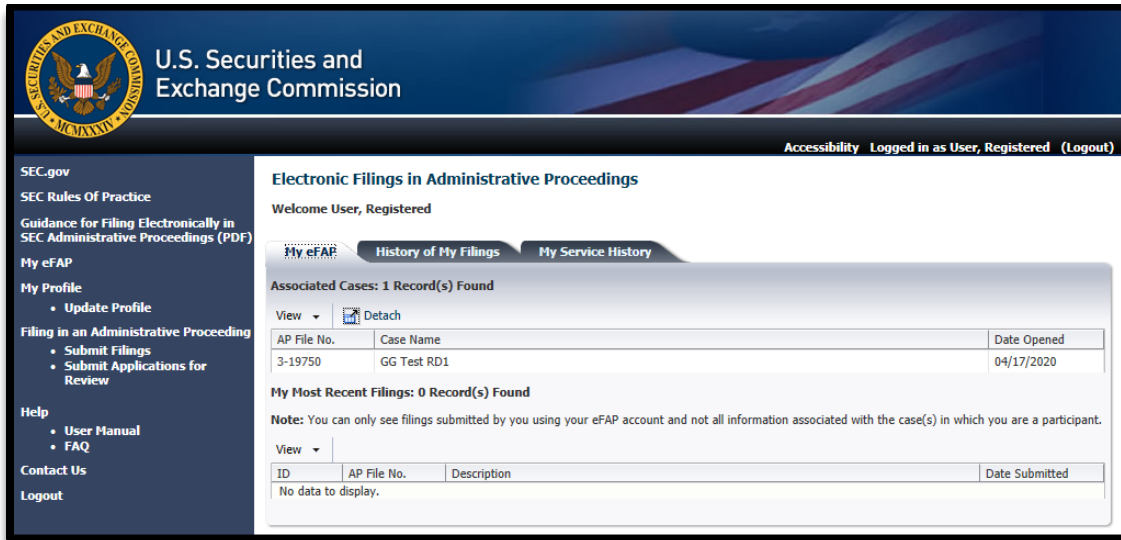


Figure 17: My eFAP page

- a) The **My eFAP** tab contains two tables:
  - i. **Associated Cases** table – shows Administrative Proceedings (AP) cases that you are affiliated with. If you are not a participant in any AP cases, this table will not appear.

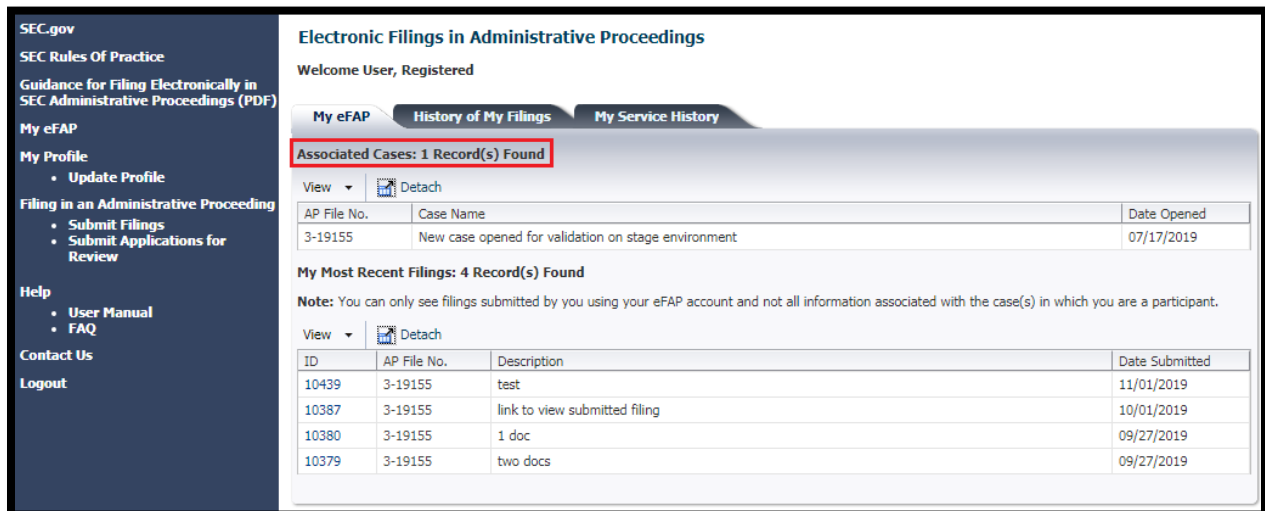


Figure 18: My eFAP page – Associated Cases table

- ii. **My Most Recent Filings** table – shows the list of filings that you have most recently submitted to eFAP.

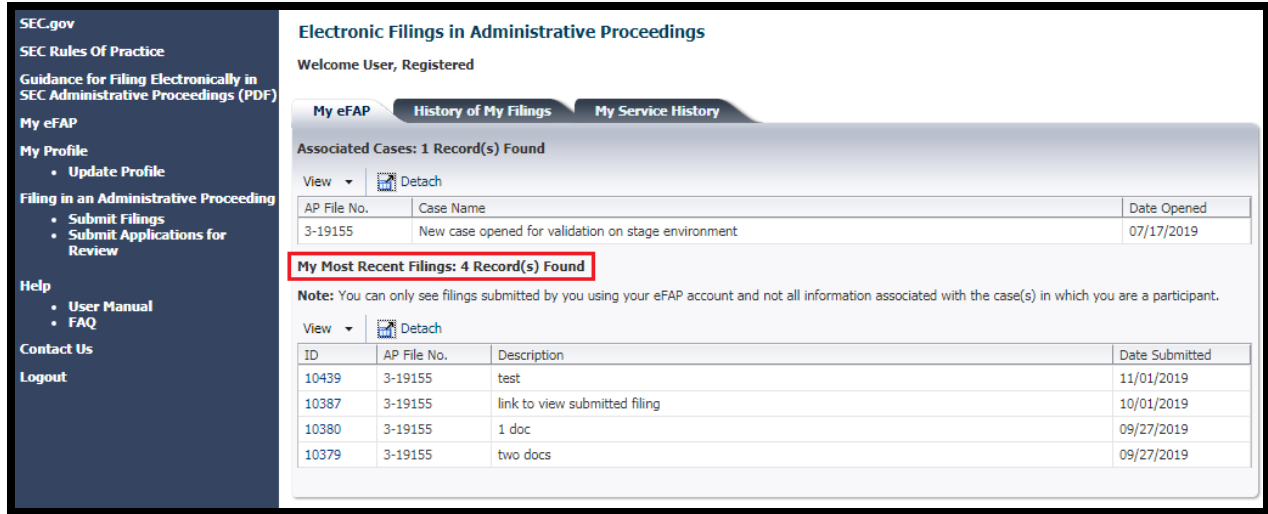


Figure 19: My eFAP page – My Most Recent Filings table

b) **History of My Filings** tab– the complete history of filings that have been submitted by you.

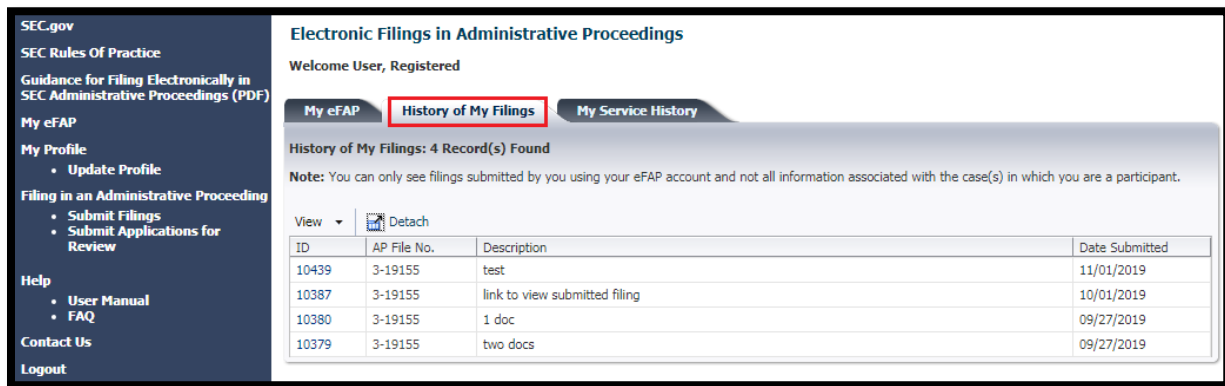


Figure 20: My eFAP page – History of My Filings tab

c) **My Service History** tab– the complete list of electronic services received by you.

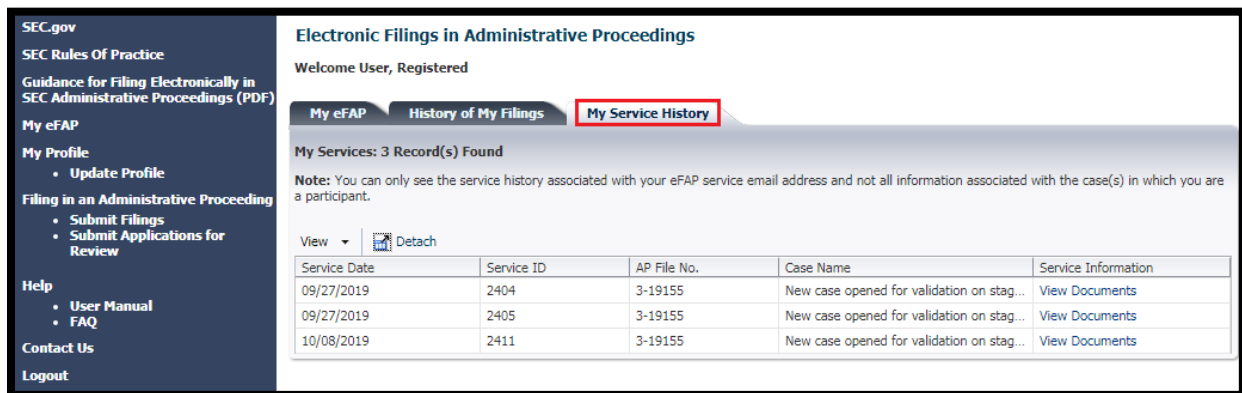


Figure 21: My eFAP page – My Service History tab

## 5 Left Navigation Toolbar

The left navigation toolbar provides the ability to quickly and easily navigate through the eFAP system. It contains hyperlinks and functions, which are explored in greater detail throughout this document. At a minimum, the navigation toolbar will always display a hyperlink for the **My eFAP** page and a hyperlink to **Logout** of the application. Except when updating your profile, the toolbar will include a hyperlink back to the **SEC.gov** website and a **Contact Us** hyperlink. Clicking the later provides additional information on how to contact the SEC's technical support resources.

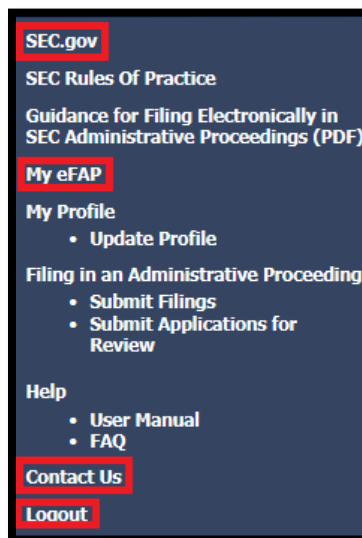


Figure 22: Left Navigation Toolbar – key links

## 6 Update User Profile

If the personal information you submitted during the registration process has changed, it can be updated in the eFAP system. This section details how to change personal information associated with your user profile and account.

- 1) After signing into eFAP, click the **Update Profile** hyperlink in the left navigation toolbar under **My Profile**.

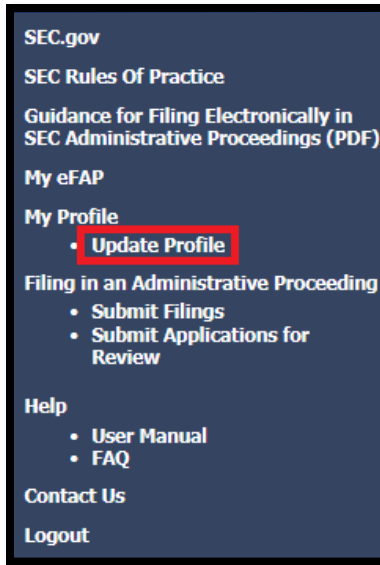


Figure 23: Update Profile link

- 2) The **Update User Profile** page with an associated left navigation toolbar will appear.

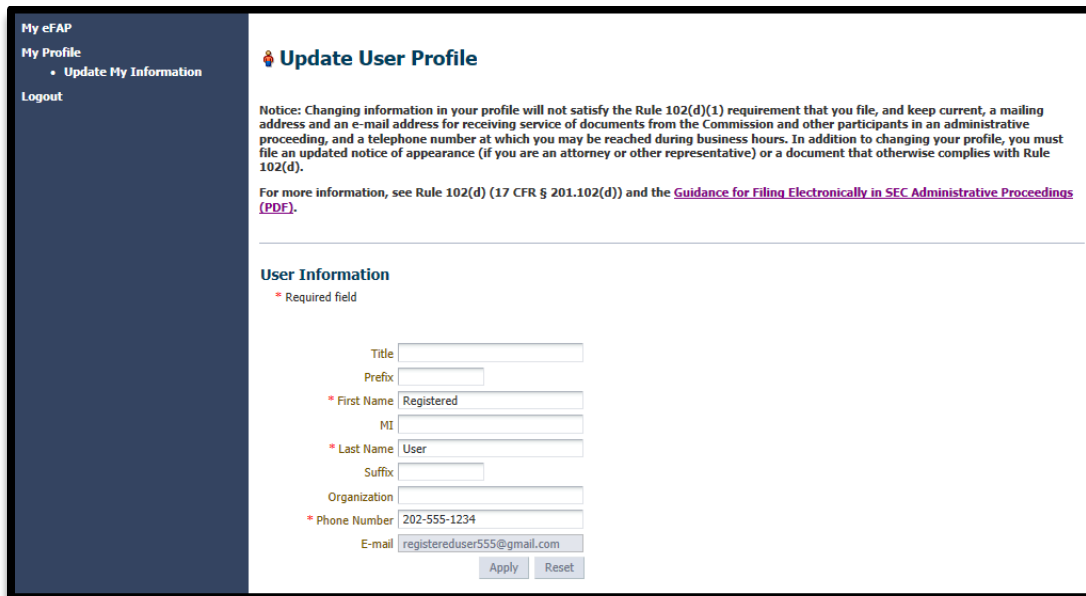


Figure 24: Update User Profile page and associated left navigation toolbar

## 6.1 Update User Information

- 1) On the **Update User Profile** page, user information associated with your eFAP account is shown. First Name, Last Name, and Phone Number, marked with a red asterisk (\*), are required fields and therefore, cannot be blank.

*NOTE: The email address, used as the username for the account, is greyed out and cannot be changed.*

- 2) After you update any user information field, the **Apply** and **Reset** buttons will be enabled. Click the **Apply** button to save your changes.

*NOTE: To undo all changes, press the **Reset** button.*

- 3) After clicking the **Apply** button, a confirmation pop-up message will appear at the top of the page confirming that your changes were saved. Click the **OK** button.

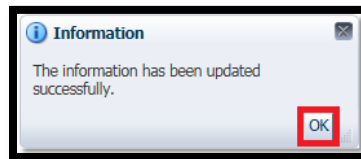


Figure 26: Update User Profile page – Information successfully updated pop-up

## 8 Filing in an Administrative Proceeding

The eFAP application provides users the ability to submit filings electronically instead of sending hard copies to SEC Headquarters. This section details the steps for submitting electronic filings and applications for review to the eFAP system.

### 8.1 Submit Filings

If you know the associated AP file number, against which you want to submit a filing, the filing can be uploaded via the **Submit Filings** function.



- 1) From the left navigation toolbar, under the **Filing in an Administrative Proceeding** section, click on the **Submit Filings** hyperlink.

- 2) The **NOTICE OF REDACTION RESPONSIBILITY** and **NOTICE OF RESPONSIBILITY TO SERVE FILINGS** page will appear. Confirm that you understand the rules regarding the redaction of Sensitive Personal Information (SPI) from documents and the serving of filings by clicking both checkboxes.

*NOTE: The **OK** button will not be enabled until you click both checkboxes.*

*NOTE: It is very important you verify that any SPI has been redacted from the documents intended to be uploaded.*

- 3) After the **OK** button is clicked, the **Submit Filings** page will appear.
- 4) Enter data into the following required fields:
  - a) **Administrative Proceeding File Number**
  - b) **On Behalf of** (who the filing is being uploaded on behalf of)

c) **Filing Description** (short description of what the filing is)

- 5) The next step would be to upload documents, which must be in PDF format, since the system only accepts files in this format. There are two methods to upload documents for the filing:
  - a) Method 1: Click the **Upload Files** (or **Browse** for Internet Explorer or **Choose Files** in Chrome) button, which opens a navigation window where you can browse for the documents located on your hard drive.

- b) Method 2: Drag and drop the files from your hard drive into the drop box which will turn blue once the file or set of files is dragged over it. Release the file(s) into the drop box.

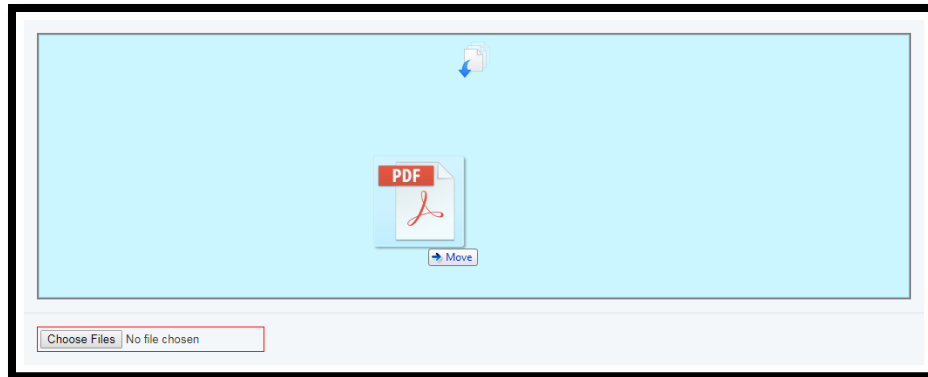


Figure 32: Upload Filings page – drop box turns blue when documents dragged over it

- 6) With either method, information about the uploaded document(s) will then appear in a new table near the bottom of the page after clicking **OK**.

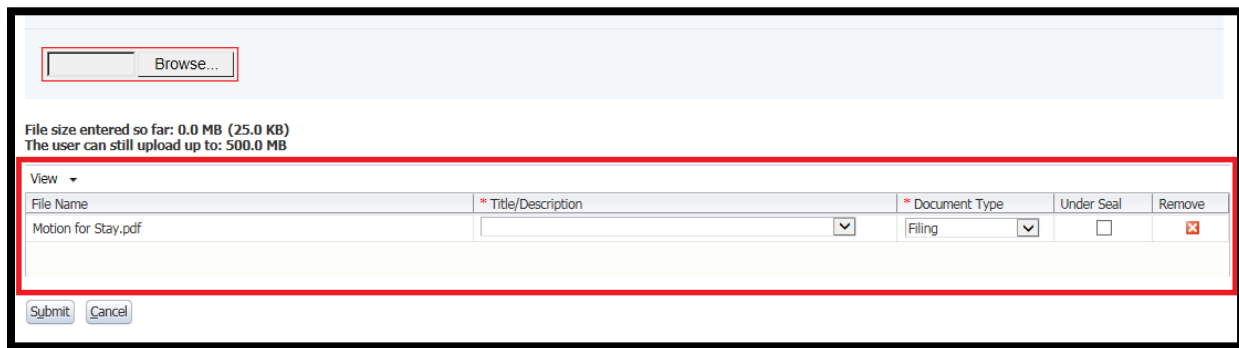


Figure 33: Submit Filings page – information on uploaded document(s) appear in a new table

- 7) The **File Name** column contains the file name(s) of the document(s) that you uploaded.

- 8) The second column contains the required field **Title/Description**. For each uploaded and listed document, select an applicable title/description from the **Title/Description** drop-down list. There are almost sixty choices in the list including Other. If you select Other, a text box will appear to allow you to enter your own title/description. If you leave the Other text box blank, eFAP will add into this field the text “Other – “ followed by the file name of the document once you click the **Submit** button.

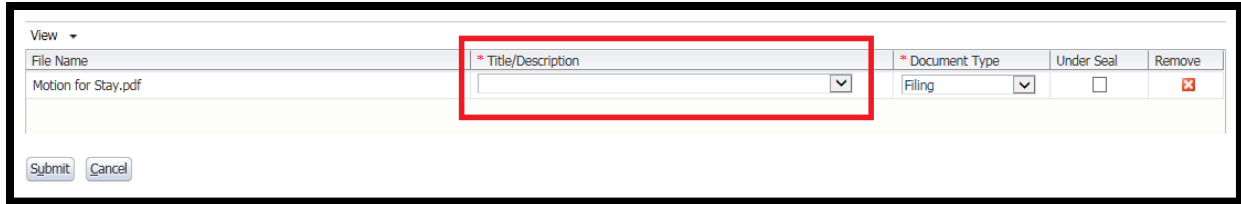


Figure 35: Submit Filings page – Title/Description drop-down list

9) The third column contains the required field **Document Type**. This field has a drop-down list. The default document type is Filing. For each uploaded and listed document, you can keep the default or select another. The options for **Document Type** are:

- Filing
- Attachment
- Hearing Exhibit/Admitted
- Hearing Exhibit/Offered Not Admitted
- Certified Record

10) The fourth column contains an **Under Seal** check box for each uploaded and listed document. For each document, select the check box under the **Under Seal** column if the document is to be filed under seal. If the document is not to be filed under seal, leave the check box unchecked.

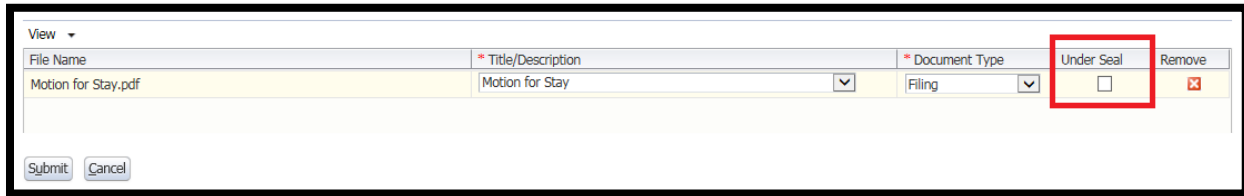


Figure 37: Submit Filings page – Under Seal check box

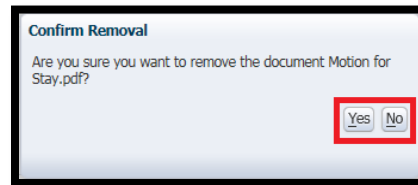


Figure 39: Submit Filings page – Confirm Removal pop-up

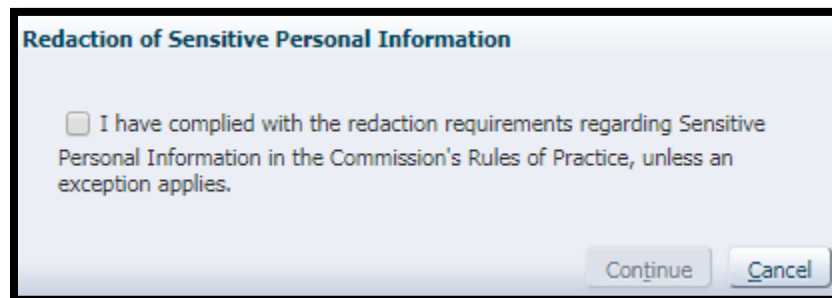


Figure 41: Submit Filings page – Redaction of SPI pop-up

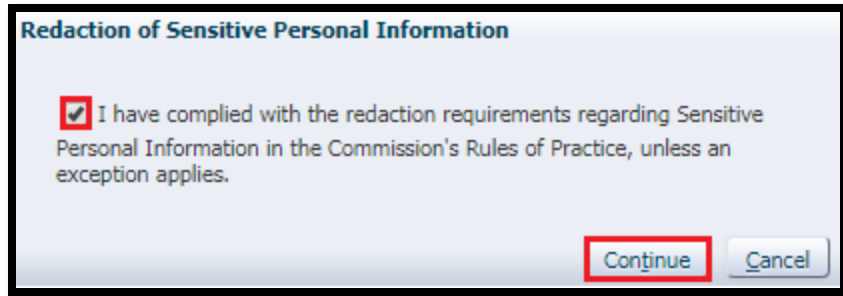


Figure 42: Submit Filings page – Redaction of SPI pop-up with Continue button enabled

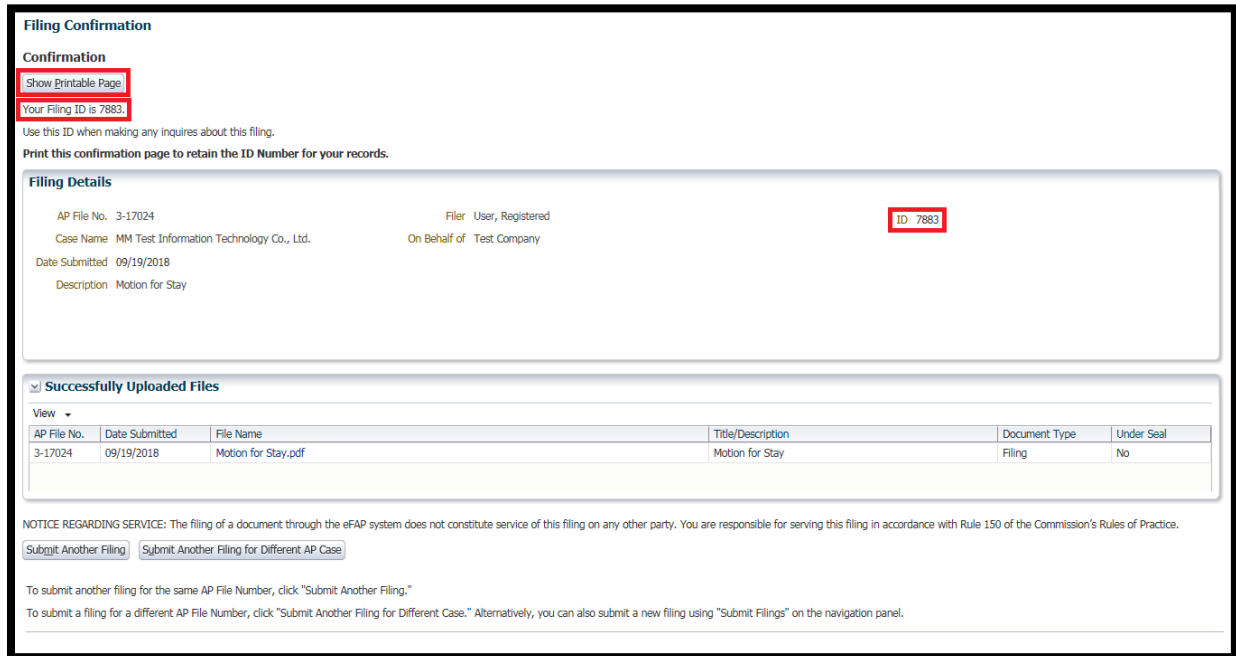


Figure 43: Filing Confirmation page – Filing ID and Show Printable Page button

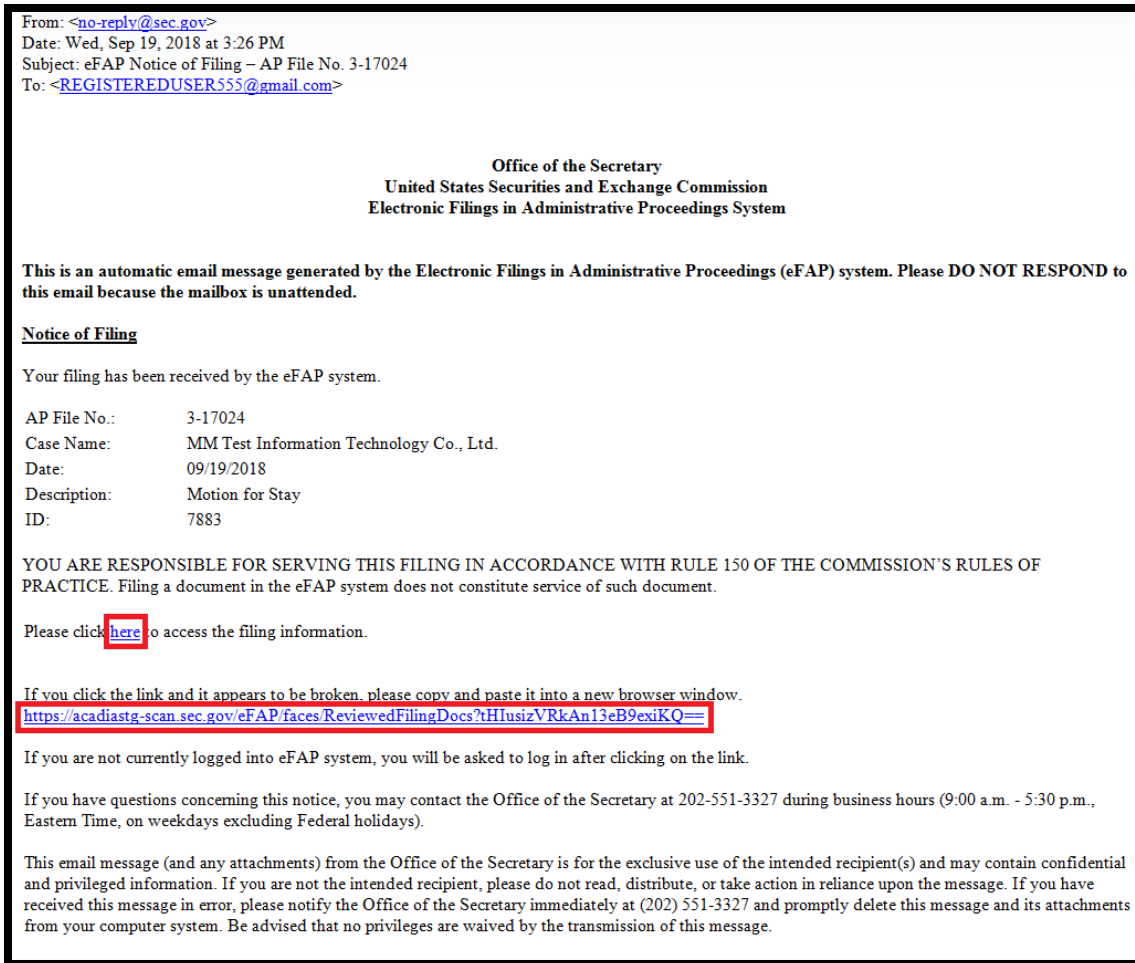


Figure 45: Notice of Filing email – links to access Filing Information page

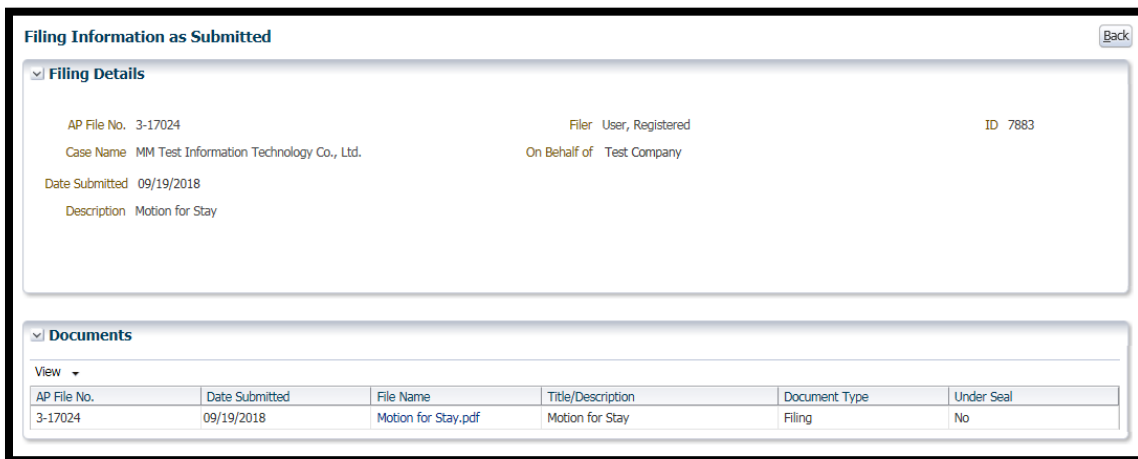


Figure 46: Filing Information as Submitted page

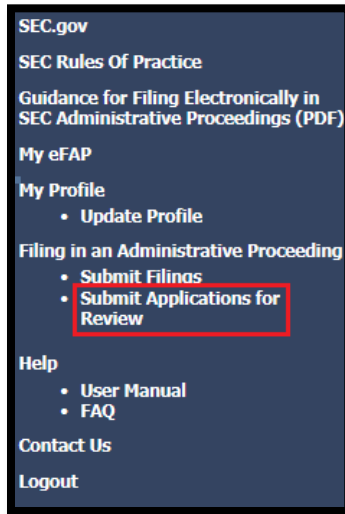


Figure 47: Submit Applications for Review link

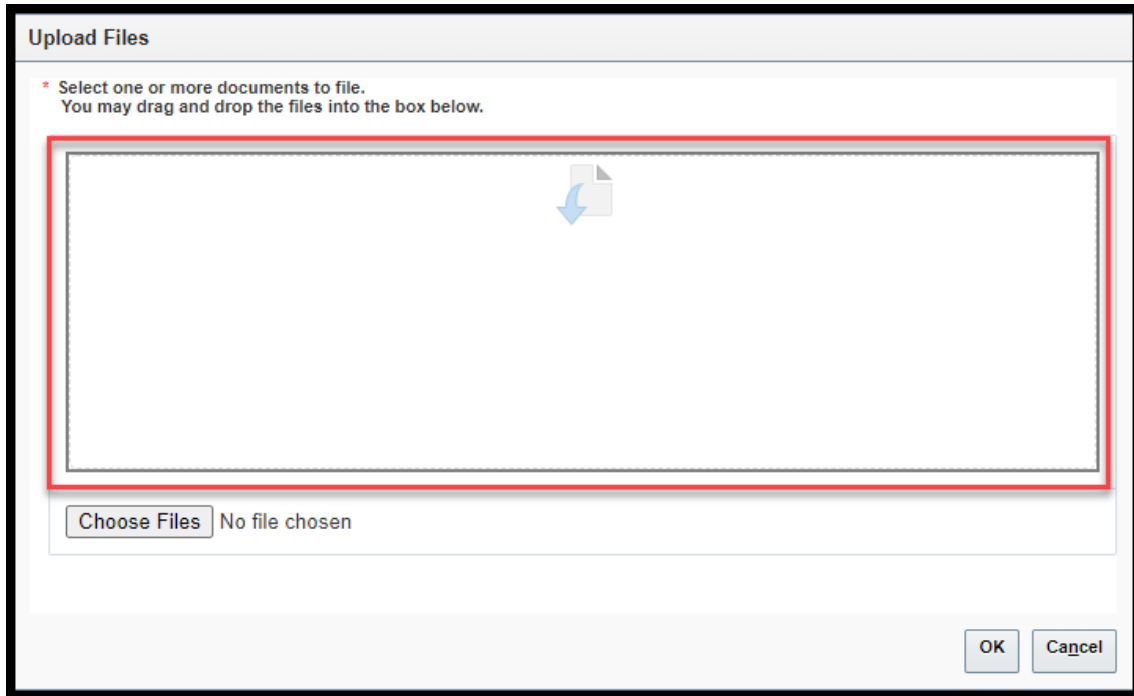


Figure 51: Upload Filings page – drag and drop box

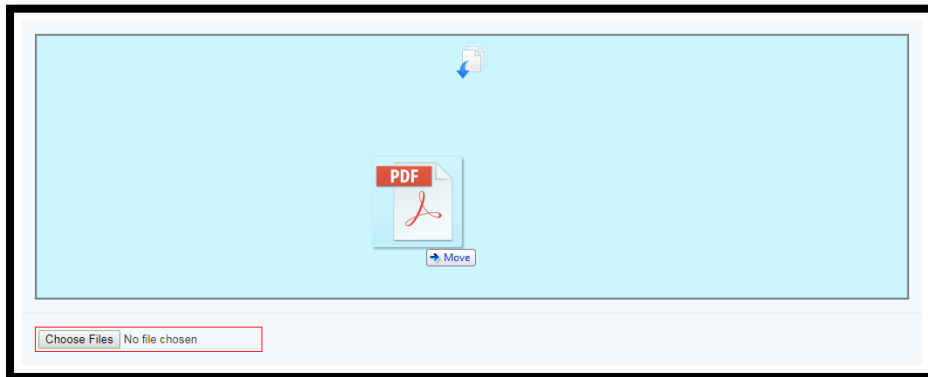


Figure 52: Upload Filings page – drop box turns blue when documents dragged over it

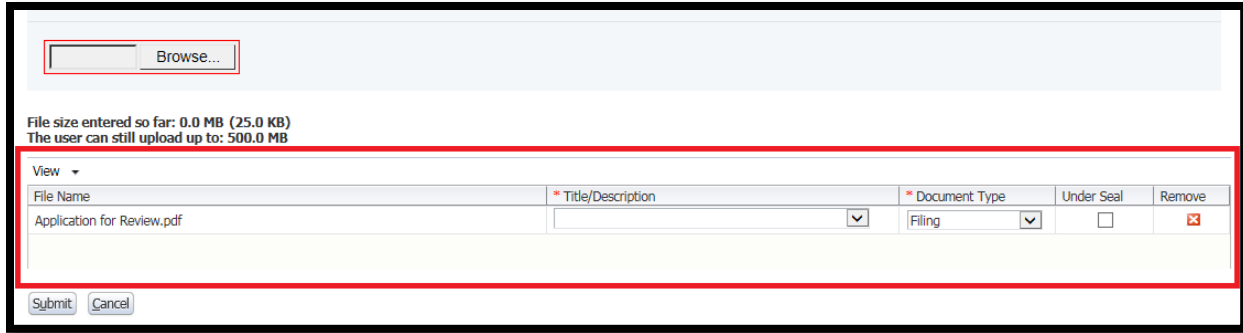


Figure 53: Submit Applications for Review page – information on uploaded document(s) appears in new table

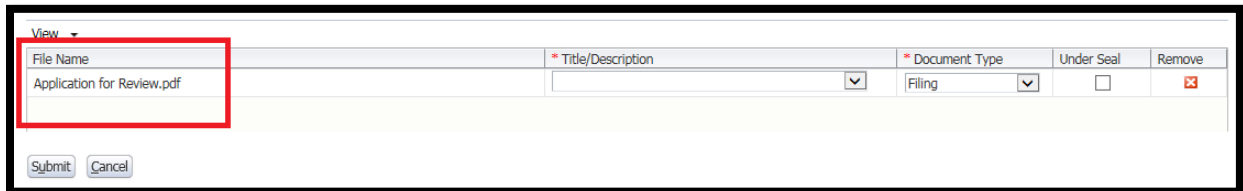


Figure 54: Submit Applications for Review page – File Name column

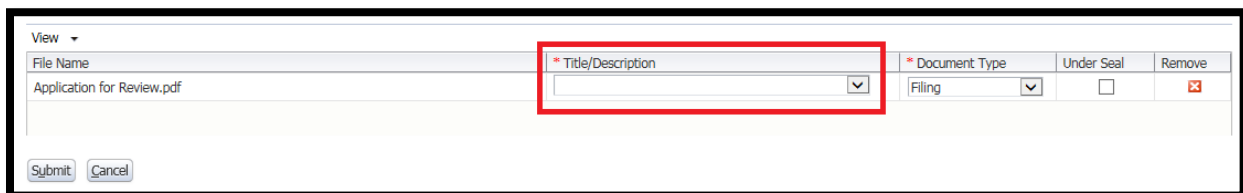


Figure 55: Submit Applications for Review page – Title/Description drop-down list

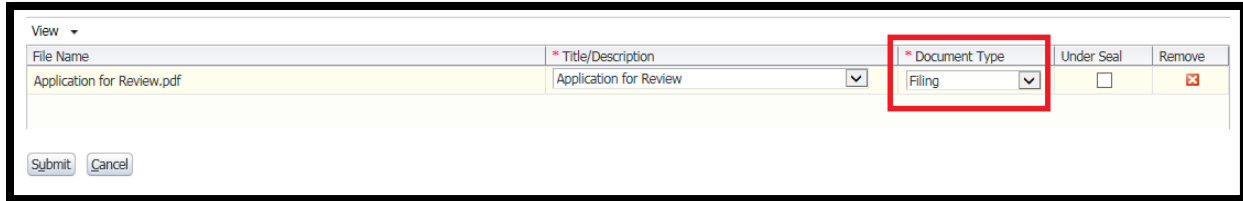


Figure 56: Submit Applications for Review page – Document Type drop-down list

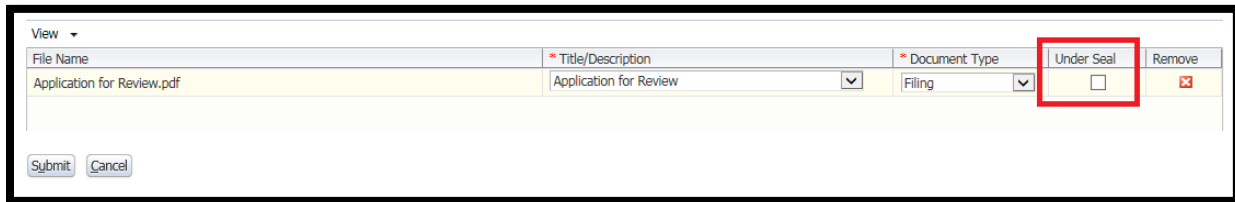


Figure 57: Submit Applications for Review page – Under Seal check box

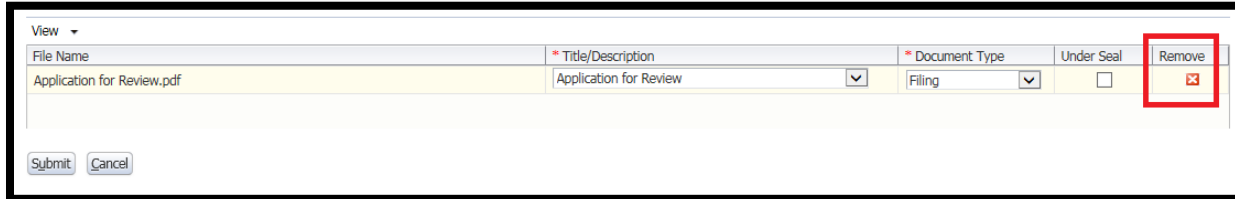


Figure 58: Submit Applications for Review – Remove document red box

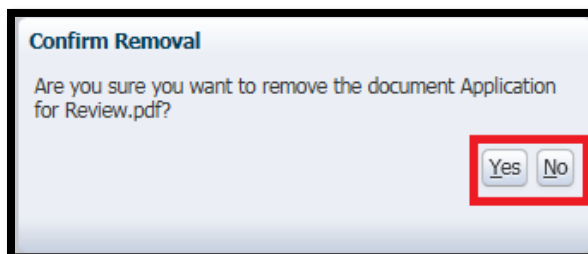


Figure 59: Submit Applications for Review – Document Removal Confirmation

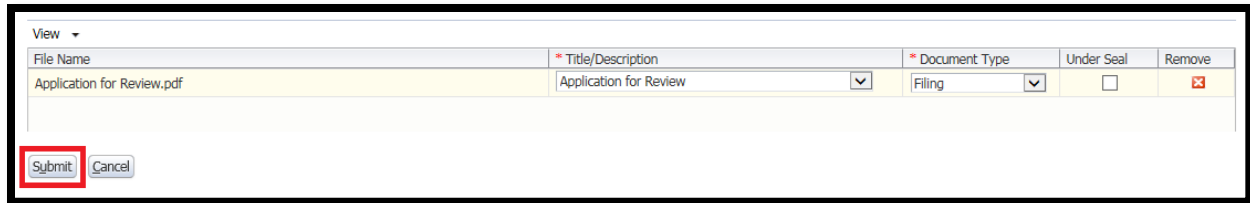


Figure 60: Submit Applications for Review page – Submit button

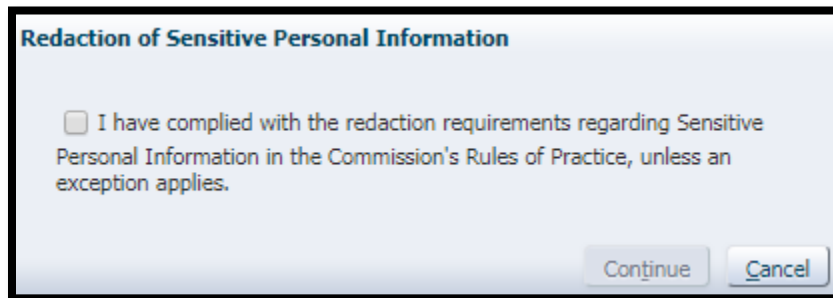


Figure 61: Submit Applications for Review page – Redaction of SPI pop-up

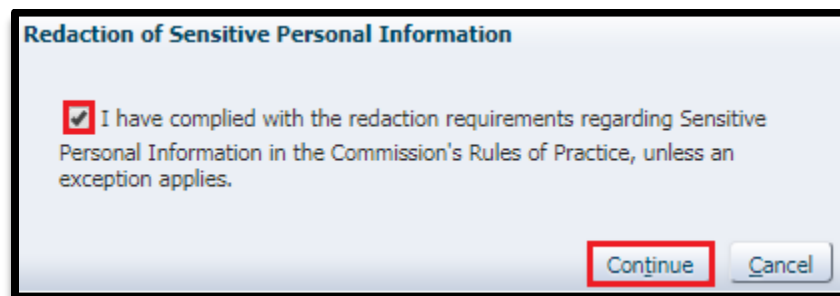
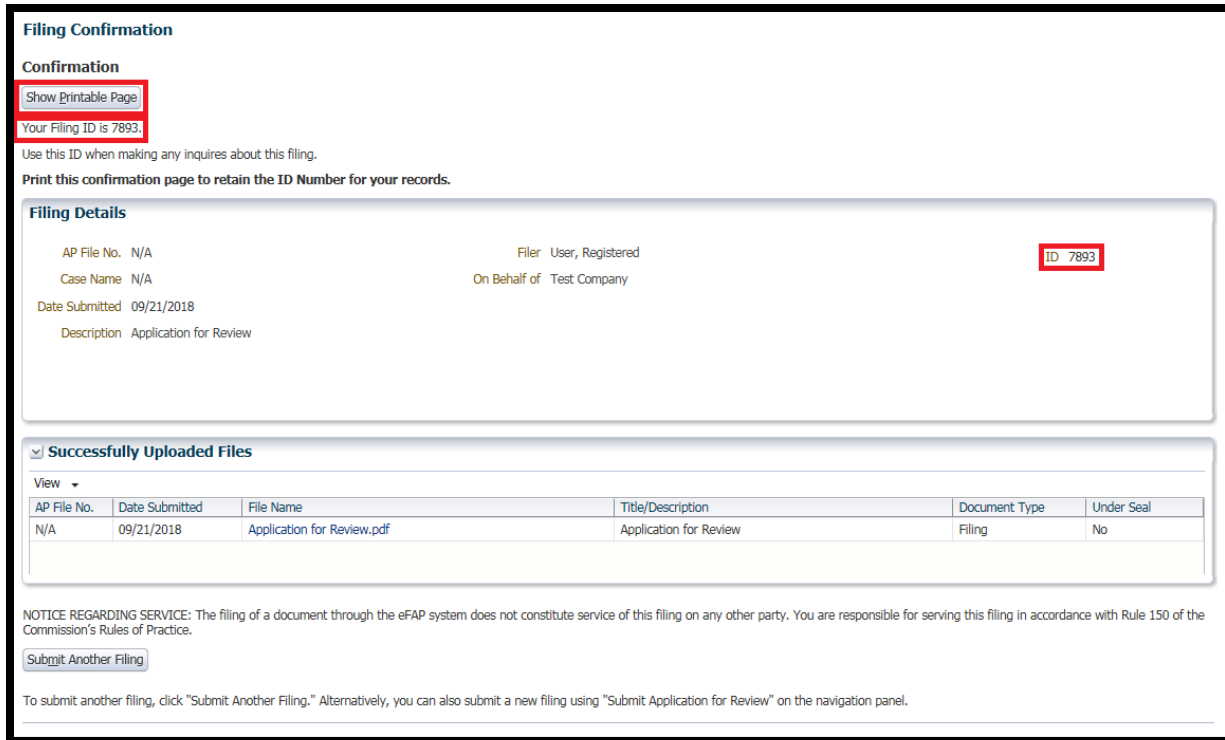


Figure 62: Submit Applications for Review page – Redaction of SPI pop-up with Continue button enabled

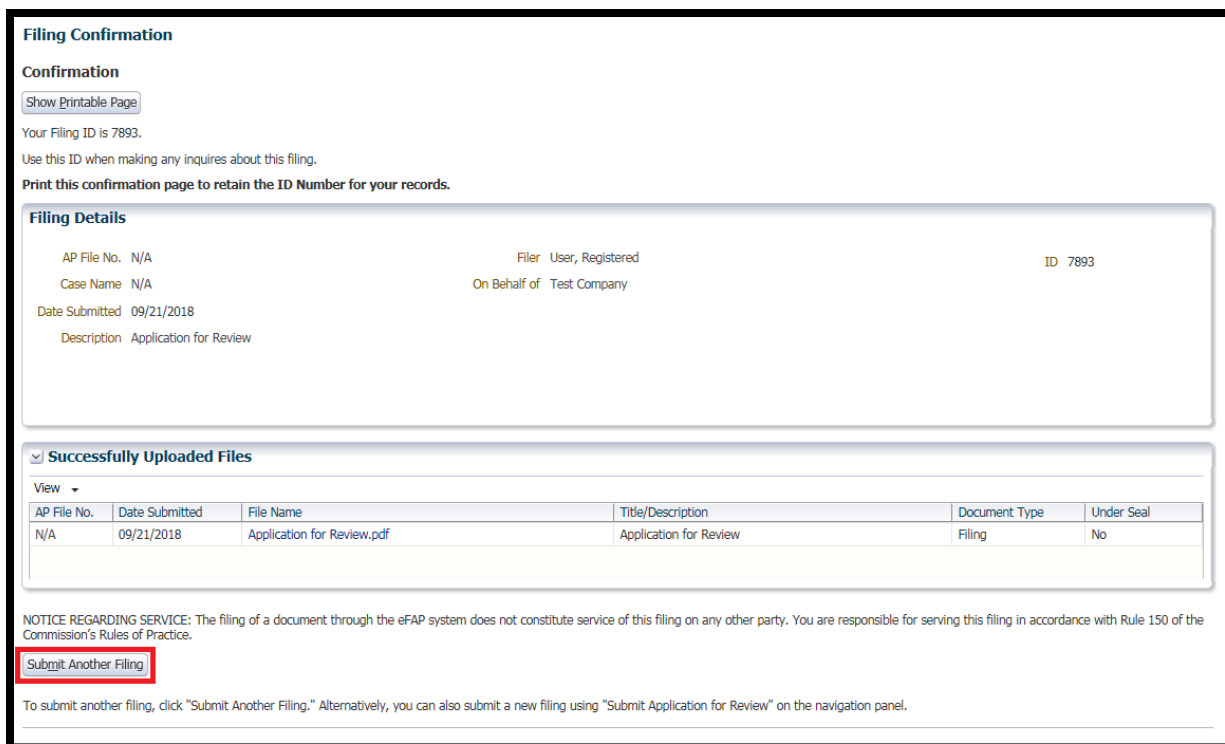

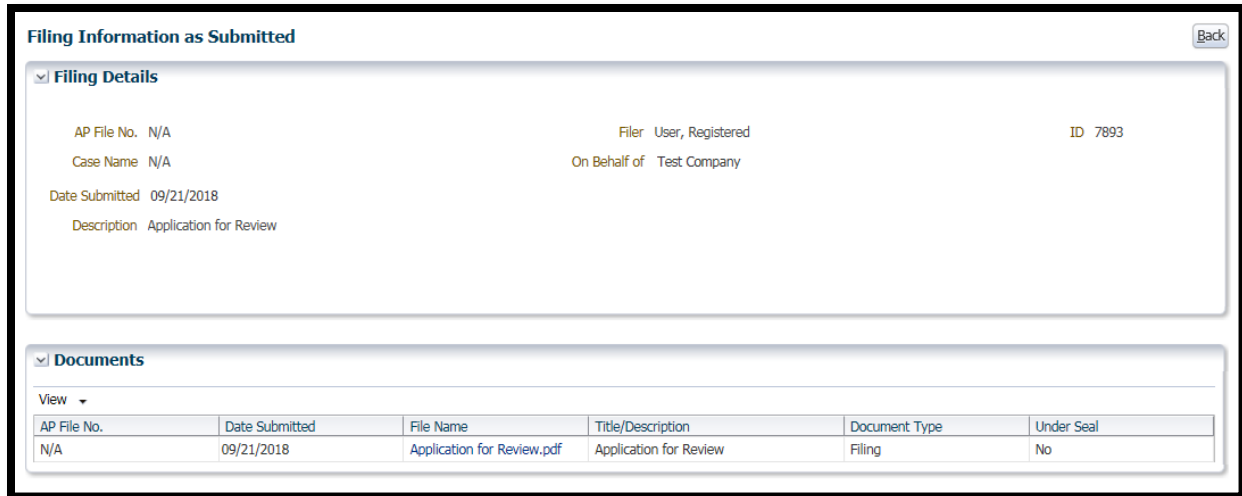


Figure 66: Filing Information as Submitted page

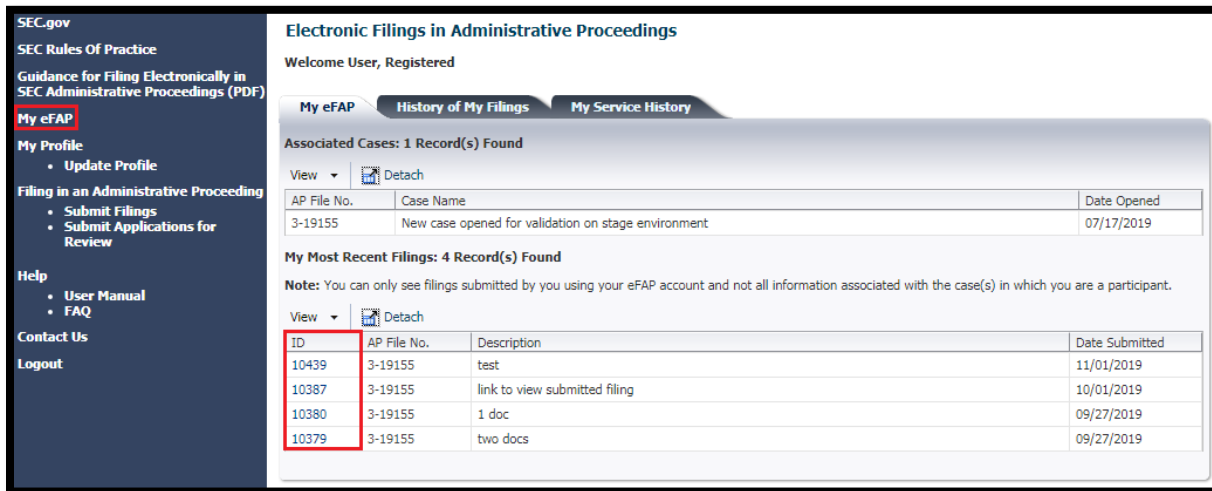


Figure 67: My eFAP page – ID number column with hyperlinked IDs

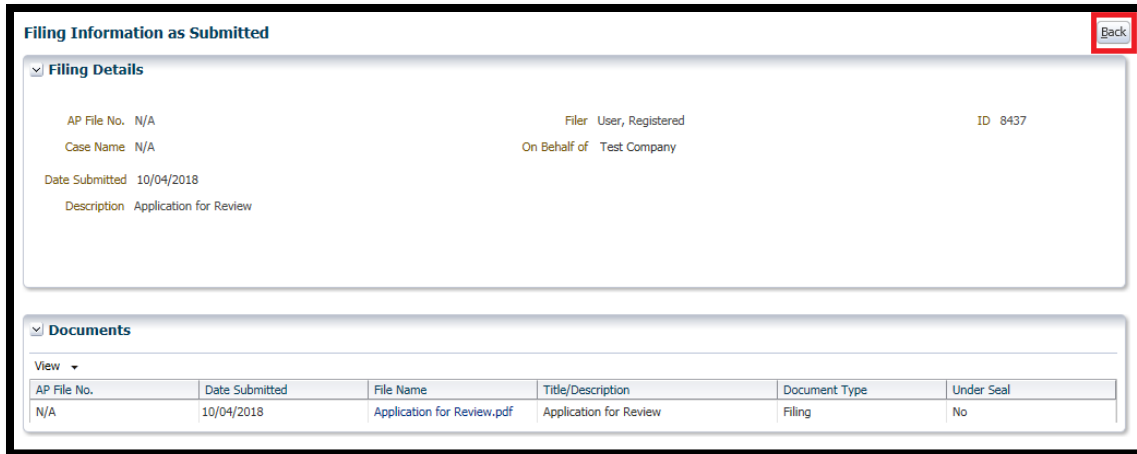


Figure 68: Filing Information as Submitted page – Back button

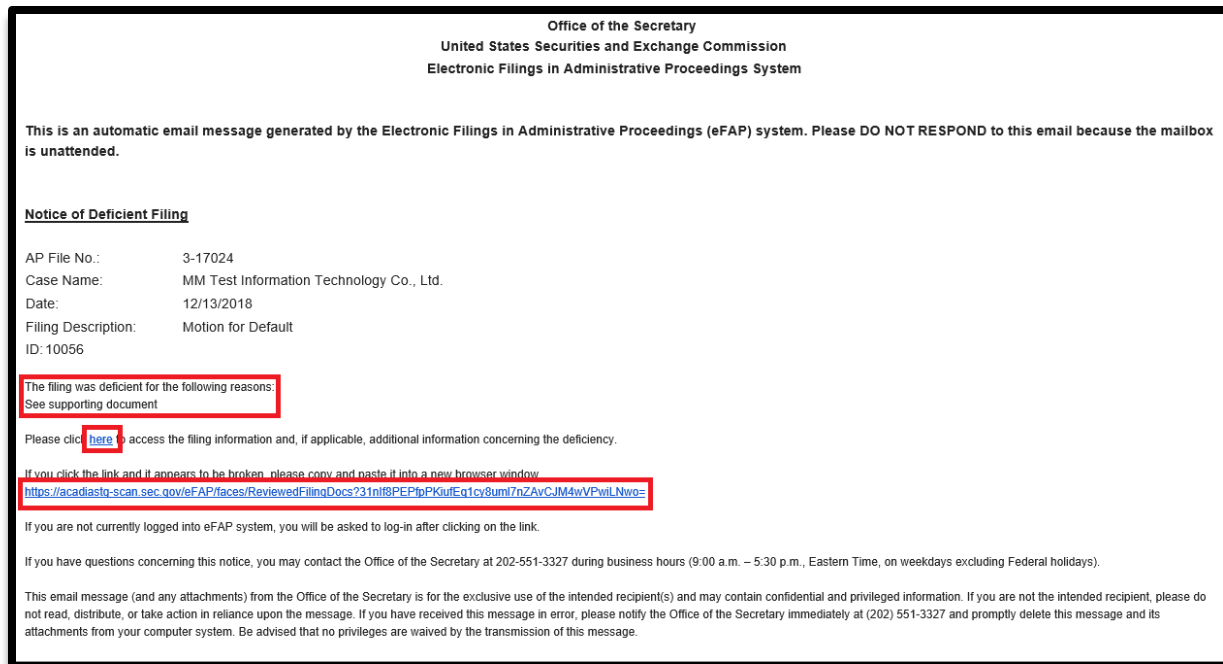


Figure 69: Notice of Deficient Filing email – reasons for deficient filing and links to filing

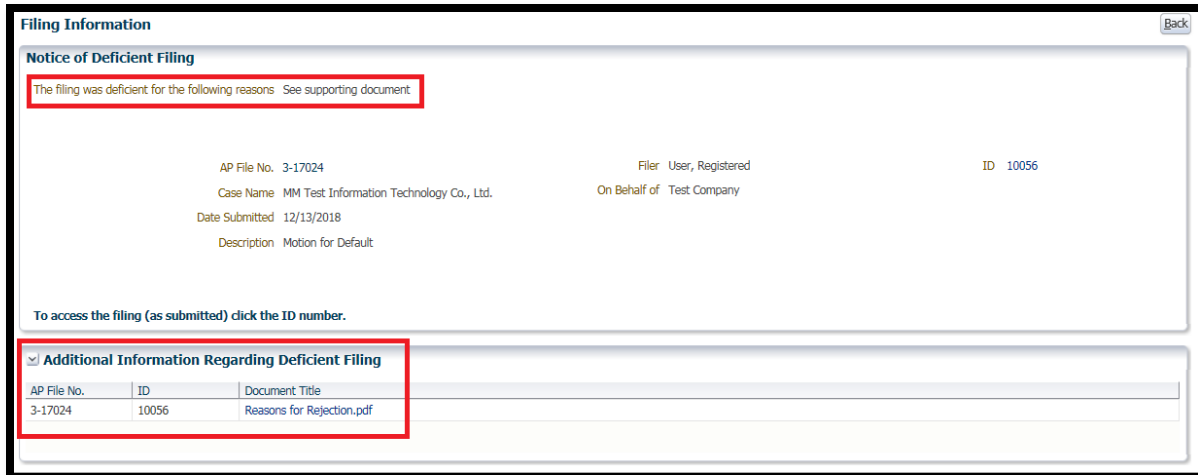


Figure 70: Filing Information: Notice of Deficient Filing page – rejection comments & additional information

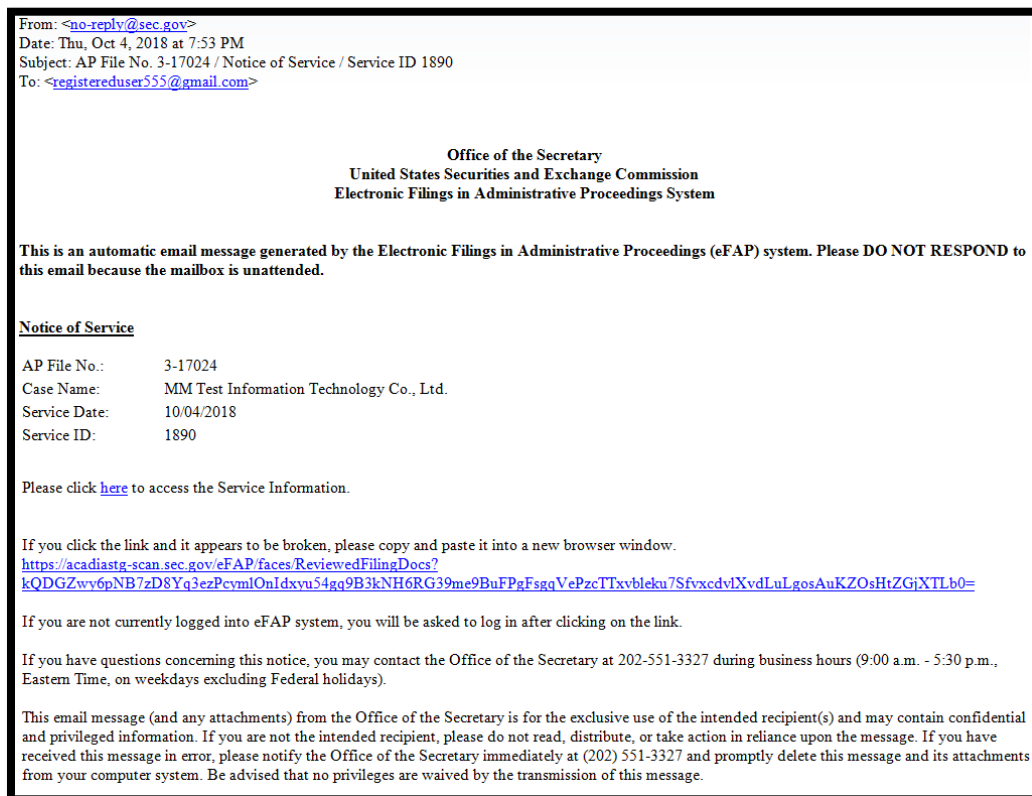


Figure 71: Notice of Service email

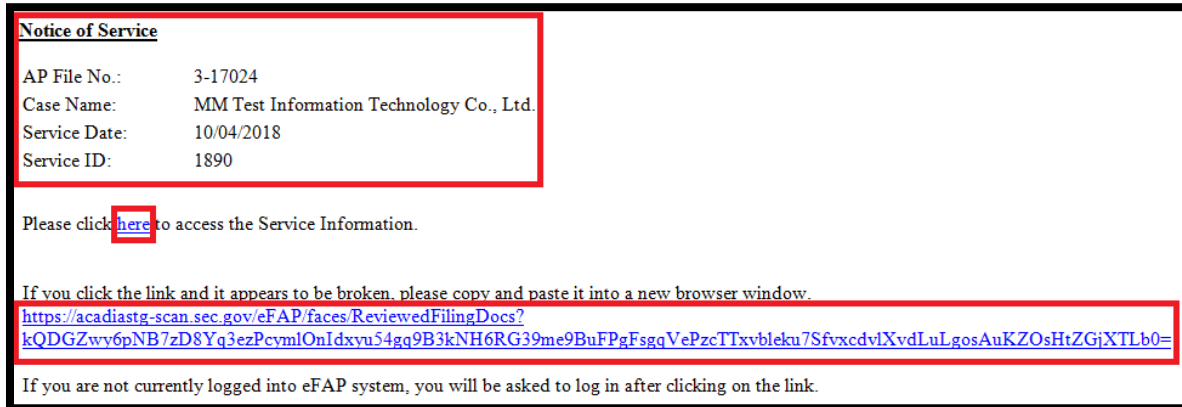


Figure 72: Notice of Service email – service information and links to Service Information page

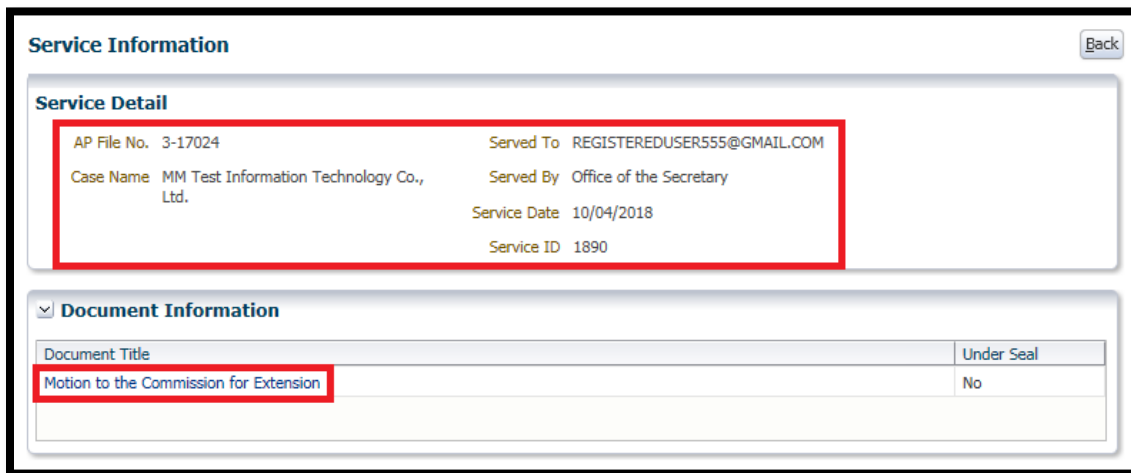


Figure 73: Service Information page – details of service and document title link

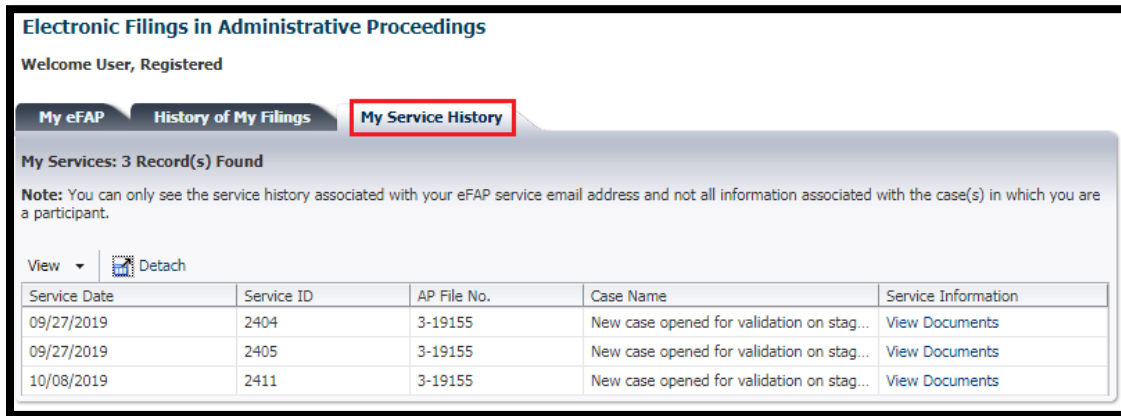


Figure 74: My eFAP page – My Service History tab

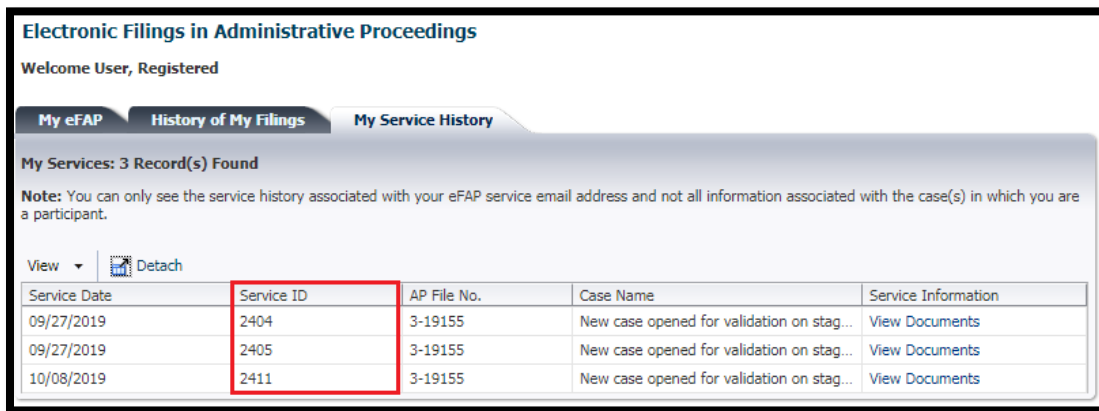


Figure 75: My Service History tab – Service ID column

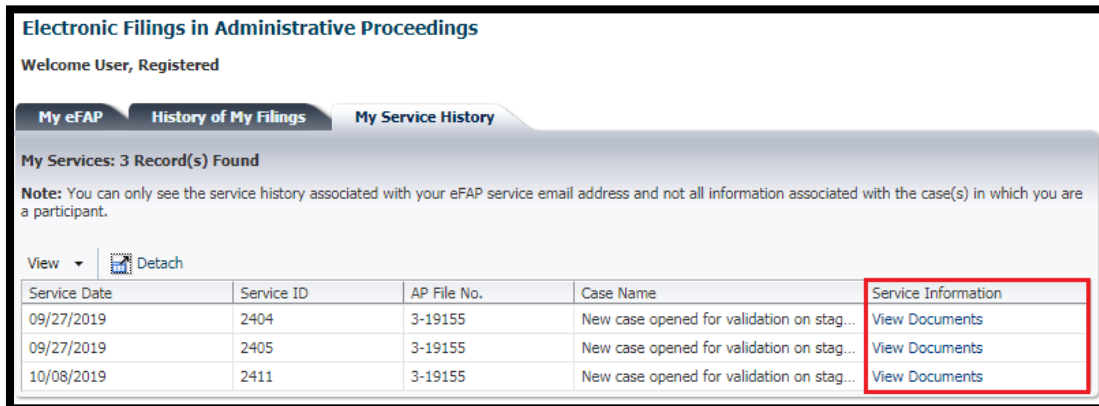


Figure 76: My Service History tab – View Documents link under Service Information column

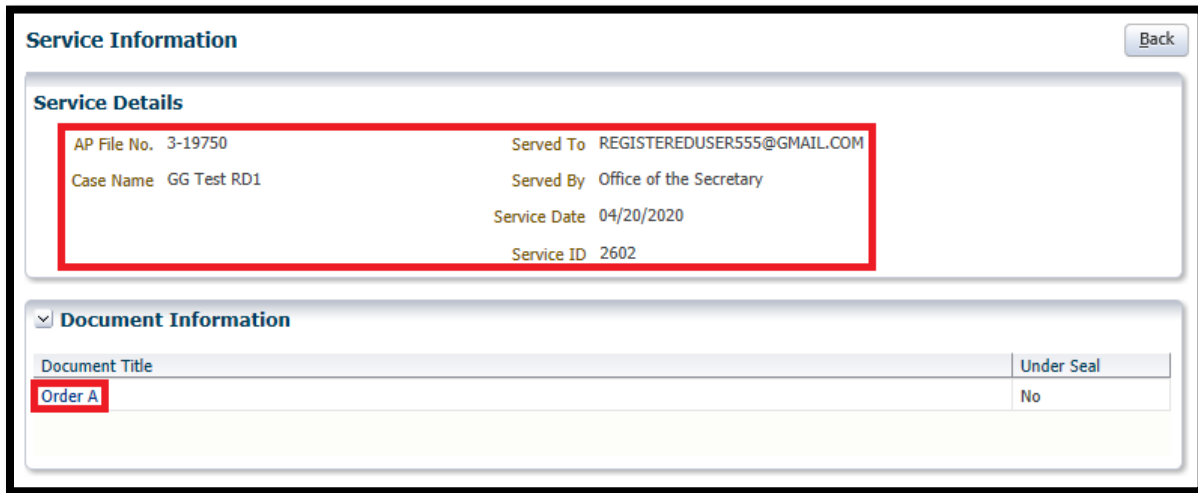


Figure 77: Service Information page – Service Details and Document Title link

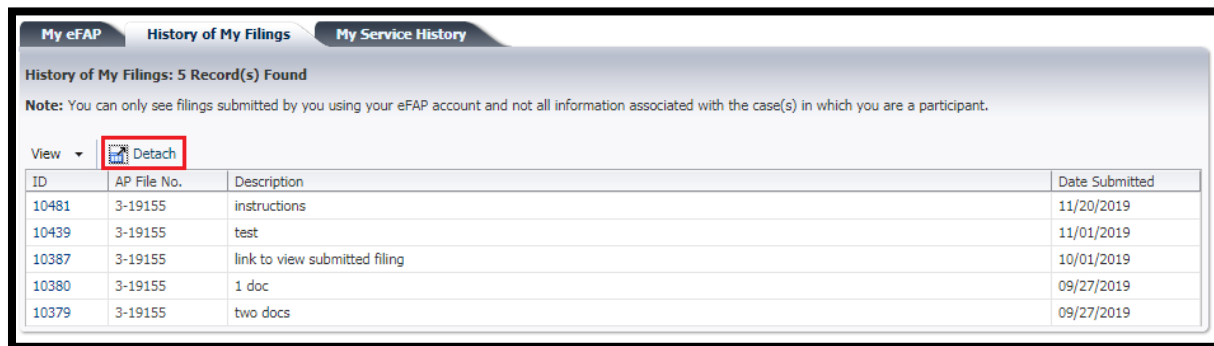


Figure 78: My eFAP page – History of My Filings tab & table – Detach button

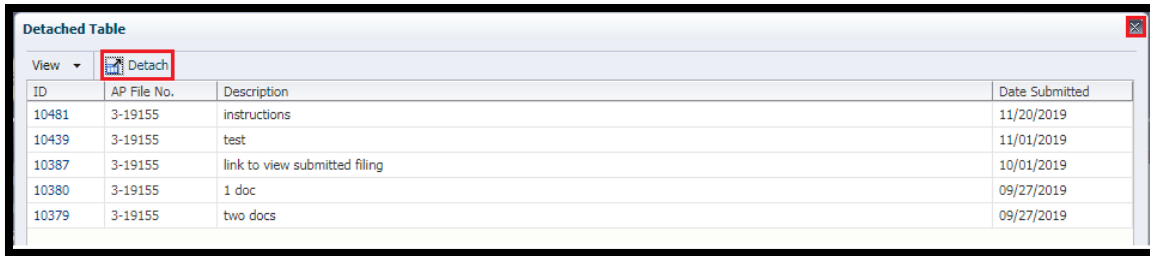


Figure 79: Detached Table window – Detach button and X box

## 11 Clear Browser Cache

If you are having issues successfully signing into/accessing eFAP, try clearing your web-browser cache. The sections below detail the steps for clearing your browser cache for two browser types.

### 11.1 Internet Explorer (IE)

To clear the Internet Explorer (IE) browser cache, complete the following steps.

*NOTE: As stated previously, IE 11 works best for the eFAP application. Depending on the version of IE that you have, the screenshots and steps below may differ slightly.*

- 1) Click the **Settings** icon near the top-right corner of the page.

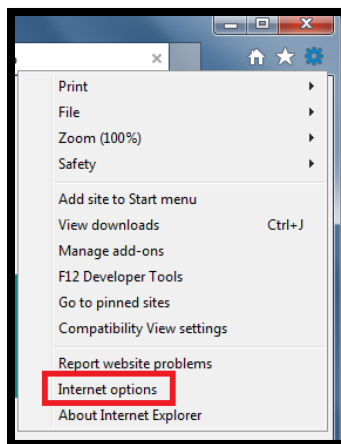


Figure 81: IE Settings drop-down list – Internet options

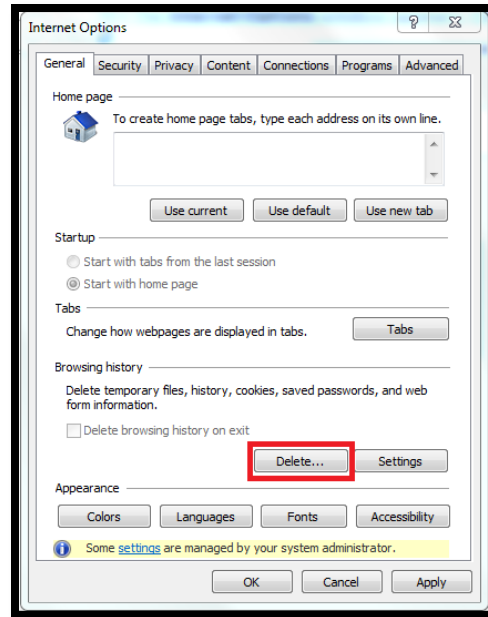


Figure 82: Delete... button

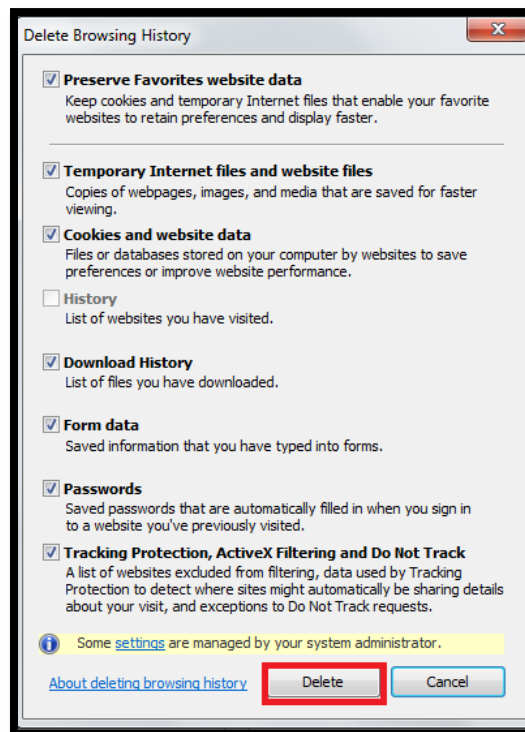


Figure 83: Delete Browser History pop-up – checked items and Delete button

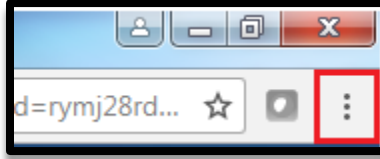


Figure 84: Top right section of Google Chrome browser page – Customize icon

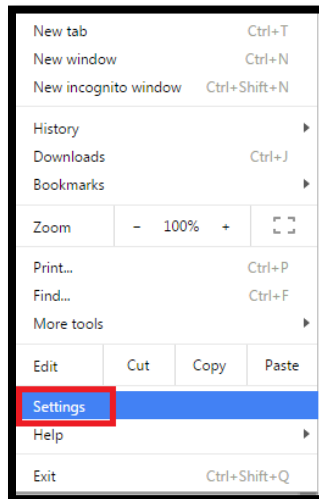


Figure 85: Customize drop-down list – Settings

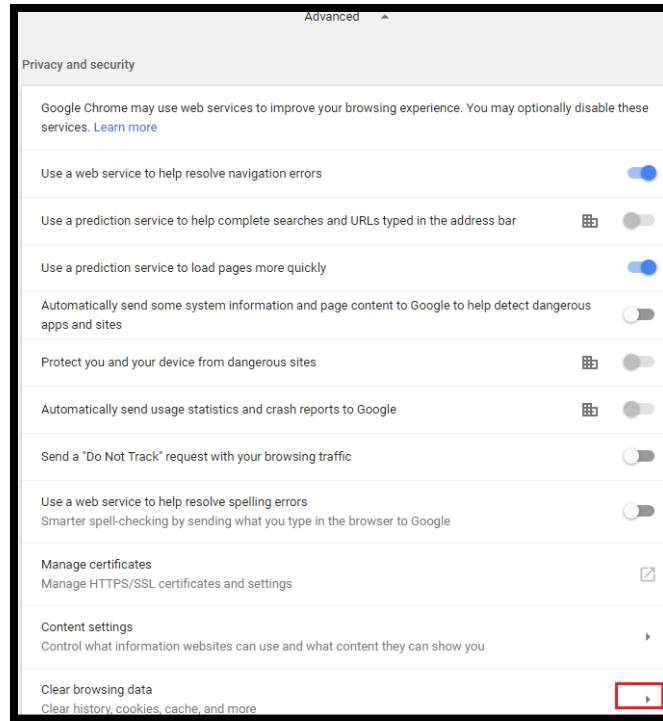


Figure 86: Chrome Settings page – Privacy and security section – Clear browsing data button

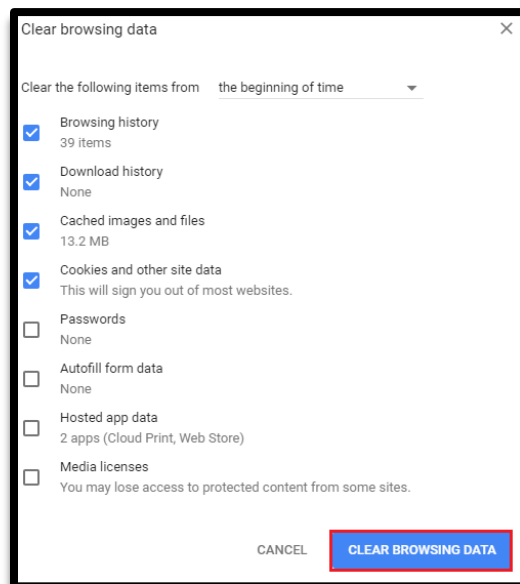


Figure 87: Clear browsing data pop-up – checked items and CLEAR BROWSING DATA button
