Applicant has diagnosed Patient with the following mental disorder or mental defect: Psychotic Disorder Not Otherwise Specified

Applicant has determined that administration of the following classes of psychoactive medication marked with an "X" is the proper and customary course of treatment for and in the best interest of Patient:

X Antidepressants X Antipsychotics X Anxiolytics/sedatives/hypnotics X Mood stabilizers ☐ Monoamine oxidase inhibitors ☐ Stimulants

A list of medications within each class as determined by the Department of State Health Services is attached as Exhibit "A".

R & C & E U & D ON 17 IV. The customary and proposed methods for administering the medications are intramuscular injections and oral medications including liquids, pills, tablets, capsules, or dissolving tablets. Applicant will administer the medications in the customary and proposed methods described herein.

V.

Patient presents a danger to Patient or others in the mental health facility, based on the following behavior and/or statements by Patient:

Patient has been charged with the criminal offense of Aggravated Assault with Deadly Weapon.

VI.

Applicant believes Patient lacks the capacity to make a decision regarding administration of psychoactive medication for the following reasons:

Patient does not believe that he has a mental illness or that he needs to take medications.

VII.

Applicant believes that if Patient is treated with the classes of psychoactive medication, specified in paragraph III above, Patient's prognosis is:

He will show improvement in symptoms, and it is more likely that he will be able to regain competency stand trial.

VIII.

Applicant believes that if Patient is not administered the classes of psychoactive medication, specified in paragraph III above, the consequences will be:

Continuation of psychotic symptoms, and he will remain incompetent to stand trial for pending criminal charges.

Applicant believes: (1) there are no alternative, less intrusive treatments other than treatment with psychoactive medications; (2) there are no alternative, less intrusive treatments that are likely to produce the same results as treatment with psychoactive medications; (3) there are no less intrusive treatments likely to secure the Patient's agreement to take the psychoactive medications; and (4) the benefits of psychoactive medication outweigh the risks of such medication in relation to Patient's present medical condition.

WHEREFORE, Applicant requests that the Court, upon hearing, enter an order, pursuant to Texas Health & Safety Code §§574.106 and 574.1065, authorizing the administration of the classes of psychoactive medication specified in paragraph III of this Application to Patient in the customary and proposed method, regardless of Patient's refusal.

ORDER FOR CUSTOMARY ADMINISTRATION OF PSYCHOACTIVE MEDICATION - FORENSIC

On the 3rd day of October, 2017, came to be heard the Application for Order to Administer Psychoactive Medication in the above styled cause, alleging that WILLIAM MAVERICK WINSLOW, hereinafter called Patient, is subject to an order from a criminal court for court-ordered inpatient mental health services, dated December 27, 2016, and both the attorney for the State and the attorney for the Patient having announced ready, and all matters of fact and law were submitted to the Court, and the Court finds:

That on file in this cause is a signed and sworn Application for Order to Administer Psychoactive Medication by Patient's physician who has examined Patient and that all necessary notices and copies of the Application have been served as required by law and that all of the terms and provisions of the Texas Mental Health Code have been complied with;

That after considering all of the evidence, including the competent expert medical or psychiatric testimony, that the allegations of the Application are true and correct and are supported by clear and convincing evidence that (i) Patient is subject to an order from a criminal court for inpatient mental health services, (ii) Patient is refusing to take the medication voluntarily, (iii) Patient is in need of psychoactive medication but lacks the capacity to make a decision regarding administration of said medication, (iv) it is in Patient's best interest to receive psychoactive medication and the medication is the proper course of treatment, and (v) Patient presents a danger to Patient or others in the inpatient mental health facility as a result of a mental disorder or mental defect as determined by §574.1065 of the Texas Mental Health Code, and that the medications shall be ordered.

The Court relied on the following evidence: judicial notice of criminal court's order for
inpatient mental health services, judicial notice of the punishment range for the criminal charge,
testimony of physician, and other
and makes its determination for the following reasons:
the patient is a danger to the patient or others in the inpatient mental health facility, is
refusing to take the medications voluntarily, that treatment is in the best medical interest of the
patient, and there are no less intrusive, effective treatment alternatives
X the patient lacks the capacity to make treatment decisions, is refusing to take the
medications voluntarily, that treatment is in the best medical interest of the patient, and there are
no less intrusive, effective treatment alternatives
the state has an important interest in the restoration of the patient's competence to
stand trial, that the medications are substantially likely to restore the patient's competence to



stand trial and are substantially unlikely to have side effects that may undermine a fair trial, that alternative, less intrusive treatments are unlikely to achieve the same results, and that treatment is in the patient's best medical interest.

Accordingly, it is ORDERED pursuant to Texas Health & Safety Code 574.106, that the physicians and medical staff at the NORTH TEXAS STATE HOSPITAL-VERNON CAMPUS, and if returned to the correctional facility to await trial, the physicians and medical staff at the TARRANT COUNTY CORRECTIONS CENTER, are authorized to administer and monitor by customary methods utilizing the prevailing standard of medical care to the Patient the following class(es) of psychoactive medication, and it is further ORDERED that if the medications are administered by the physicians and staff at the TARRANT COUNTY CORRECTIONS CENTER that law enforcement is authorized to use reasonable restraint in the administration and monitoring of the medication to ensure the safety of the Patient and those administering and monitoring the medications:

antidepressants	monoamine oxidase inhibitors
antipsychotics	mood stabilizers
X anxiolytics/sedatives/hypnotics	stimulants

A list of medications within each class as determined by the Texas Department of Mental Health and Mental Retardation is attached as Exhibit "A".

It is also ORDERED that during the period this Order is valid, the dosage of the herein authorized class(es) of psychoactive medication can be increased or decreased, and restitution of medication authorized but discontinued and the substitution of a medication within the same class(es) are permitted.

This Order expires on the earliest of the following dates: the 180th day after the date Patient is returned to the correctional facility, the date Patient is acquitted, convicted, or enters a plea of guilty, or the date on which the criminal charge in this case is dismissed.

A copy of this Order to the Patient and the Patient's attorney shall serve as written notification of the court's determination.
